Welcome: Vice-President John declared the meeting open at 5:00 pm.

Moved John Crossman, Seconded Barb McCleave: that the apologies be accepted. Carried.

Minutes: No Minutes from the previous meeting were presented.

Treasurer's Report:

Correspondence:
No inward or outward correspondence was tabled.

Reports: No reports were either tabled or verbally presented:

General Business:

Moved Barbara McCleave, Seconded Bev Reichman: that we inform Colin Malcolm that as his residential circumstances have changed, he is no longer in a position to be our greenkeeper and that we have unfortunately had to terminate his services. Carried.
Note: The secretary to write to Nadine Simpson and Colin to inform them of this decision.

Moved John Fisher, Seconded Barbara McCleave: that John Crossman be appointed greenkeeper. Carried.

Moved John Fisher, Seconded John Crossman: that the club approach Hawkeye Cleaning Services with a view to them cleaning the clubhouse on a regular basis - monthly in the off season and fortnightly during the season and more often if the need arises. Carried.
Note: The secretary to contact Hawkeye Cleaning Services.

It was moved Bev Reichman, Seconded Barbara McCleave: that an order for our new shirts be placed with Fashion Club Wear. Carried.
Note: we have confirmed orders for 64 shirts, but there are still a small number of members who have not yet submitted an order.
Note: we will stock a small number of extra shirts and so the order will be for 80 shirts.

It was agreed that the secretary contact Rebecca Saunders and inform her of the requirements for her 21st celebration, scheduled to be held at the club on Saturday, July 30th. She will be informed that there will be a COVID marshall in attendance at all times and that he/she will ensure that current restrictions are fully complied with. At this point in time, the restrictions allow us to operate under the 2/sq metre rule which means there can be 90 people in the clubhouse. However, there can be no singing or dancing, patrons must be seated, there can be no shared food plates and there can only be table service of alcohol and food. Patrons must wear a mask when standing or moving within the clubhouse.

We believe that these restrictions make the celebration problematic at best. Rebecca will be made aware that our preference is for her to cancel her celebration and that we may rescind our decision to approve her party if restriction don't ease.
